5. All students are required to pay a refundable caution deposit of ₹10,000/- along with the first installment of tuition fees.
6. All students are required to pay ₹3,000/- towards the membership of Alliance Alumni Association and ₹1,500/- towards the convocation fees along with the first installment of tuition fees.
